### Goals of the Collaborative Management Program (CMP)

- Develop a more uniform system of collaborative management that includes the input, expertise, and active participation of family advocacy organizations
- Reduce duplication and eliminate fragmentation of services provided to families
- Increase the quality, appropriateness, and effectiveness of services delivered to these children and families
- Encourage cost sharing among service providers
- Ultimately lead to better outcomes and cost -reduction for the services provided to children and families in the state of Colorado





#### NonMandated Partners

- Many CMP sites choose to have non
   mandated partners sign their
   Memorandum of Understanding (MOU)
   and participate in the Interagency
   Oversight Group (IOG).
- Examples include:
  - Fam ily or Youth Representatives
  - o Family Resource Centers
  - O Juvenile Assessment Centers
  - Colorado Youth Detention Continuum
  - Community-based organizations

#### Family and Youth Voice on the IOG

- Although not mandated partners, family voice is encouraged in many parts of the CMP statute and rule.
- C.R.S. 24-1.9-101(3)(a): The development of a more uniform system of collaborative management that includes the <u>input, expertise</u>, and active participation of parent advocacy or family advocacy organizations...
- C.R.S. 24-1.9-102(1)(d): In developing the memorandums of understanding, the general assembly strongly encourages the parties to the memorandums of understanding to seek input, support, and collaboration from key stakeholders in the private and nonprofit sector, as well as <u>parent advocacy or family advocacy organizations that represent family members or caregivers of children who would benefit from multi-agency services.</u>

### Individualized Service and Support Teams (ISSTs)

The goal of an Individualized Service and Support Team (ISST) meeting is to develop an integrated action plan to address the complex issues and safety needs of the children and family.

#### **ISST General Rules**

- 2 or m ore system partners (IOG m em bers) m ust be present
- Family member present
- An integrated plan is created





# Individualized Service and Support Teams (ISSTs)

- Crossover Youth Practice Model Meetings (Child Welfare + Juvenile Justice)
- Truancy Intervention Meetings (Education + Child Welfare + Health/Mental Health)
- Restorative Justice Circles
   (Juvenile Justice + Education + Health/Mental Health)





### **CMP Prevention Programs**

- CMP prevention programs must demonstrate a multi -systemic approach.
- Programs must demonstrate that multiple disciplines were involved in the:
  - development;
  - or enhancement of the program;
  - or that multiple agencies are involved in the delivery of the service.
- Programs must demonstrate that the program was developed to reduce bifurcated services.
- Must articulate how the joint approach will benefit children, youth, and/or families in their communities.





#### CMP Prevention Programs

- Truancy Prevention/Diversion (Education + Child Welfare + Health/Mental Health)
- Parenting Education and Support Programs (Child Welfare + Health/Mental Health)
- Medical and Behavioral Health Care Coordination (Health/Mental Health + Education + Child Welfare)
