Emergency Drill White Paper for Public Schools, Charter Schools, and Junior Colleges Based on the 2021 International Fire Code

Intent of the paper -

Fire & Evacuation and Lockdown drills are a vital component in preparing our students, teachers, and staff for potential emergencies. With the recent adoption of the 2021 edition of the International Fire Code (IFC), the Division of Fire Prevention and Control is developing this paper to clarify the requirements for school fire safety plans, fire evacuation plans, and lockdown plans for Colorado schools.

INTRODUCTION

Each school should have a specific plan (Fire Safety, Fire Evacuation, and Lockdown), developed in consultation with appropriate fire (and ideally law enforcement) officials, on how to best respond to emergency incidents.

The State of Colorado has adopted the 2021 edition of the International Fire Code and that code is applicable to every public and charter school in the State. The State's adopted Fire Code requires schools to conduct a fire drill within ten days of the first day of school and once a month thereafter. The Code does not allow for the substitution of any other type of drill (e.g. lockdown, lockout, or shelter) for a fire drill. The following is a comparison of the actions that need to be taken upon an alarm notification:

- 1. If the fire alarm activates and there are no specific threats against the school or individuals, evacuate immediately upon the alarm sounding. While evacuating, maintain situational awareness for other possible dangers.
- 2. In the event that the fire alarm activates while the school is on **lockdown** it may not be appropriate to evacuate immediately and administration should immediately convey direction to staff if evacuation is being delayed.
 - If it is safe to do so and no signs of fire are apparent, appropriate staff may attempt to identify the source of the alarm activation and determine whether there is indeed a fire. Administration and/or the emergency responders who initiated the lockdown may use the intercom, public address system, or voice evacuation command center microphone to direct evacuation, as appropriate.
 - If smoke or fire is present, evacuate and maintain situational awareness while doing so. Consider other means to evacuate – such as windows – if appropriate.

REQUIRED PLANS

Fire Safety Plans, Fire Evacuation Plans, and Lockdown Plans are all governed by the provisions of Chapter 4 of the International Fire Code. The code requires that all three plans be reviewed and approved by the fire code official. The chapter prescribes the required content for each of those plans and we are presenting portions of those requirements pertinent to Schools here for your reference:

Fire Safety Plans

IFC section 404.2.2 says fire safety plans shall include the following:

- 1. The procedure for reporting a fire or other emergency.
- 2. The life safety strategy including the following:
 - Procedures for notifying occupants, including areas with a private mode alarm system.
 - Procedures for evacuating occupants, including those who need evacuation assistance.
- 3. Site plans indicating the following:
 - The occupancy assembly points.
 - The locations of fire hydrants.
 - The normal routes of fire department vehicle access.
- 4. Floor plans identifying the locations of the following:
 - Exits.
 - Primary evacuation routes.
 - Secondary evacuation routes.
 - Accessible egress routes.
 - Areas of refuge.
 - Exterior areas for assisted rescue.
 - Refuge areas associated with smoke barriers and horizontal exits.
 - Manual fire alarm boxes.
 - Portable fire extinguishers.
 - Occupant-use hose stations.
 - Fire alarm annunciators and controls.
- 5. A list of major fire hazards associated with the normal use and occupancy of the premises, including maintenance and housekeeping procedures.
- 6. Identification and assignment of personnel responsible for maintenance of systems and equipment installed to prevent or control fires.
- 7. Identification and assignment of personnel responsible for maintenance, housekeeping and controlling fuel hazard sources.

Fire Evacuation Plans

IFC section 404.2.1 says fire evacuation plans shall include the following:

- 1. Emergency egress or escape routes and whether evacuation of the building is to be completed by selected floors or areas.
- 2. Procedures for employees who must remain to operate critical equipment before evacuating.
- 3. Procedures for the use of elevators to evacuate the building where occupant evacuation elevators complying with Section 3008 of the *International Building Code* are provided.
- 4. Procedures for assisted rescue for persons unable to use the general *means of egress* unassisted.
- 5. Procedures for accounting for employees and occupants after evacuation has been completed.
- 6. Identification and assignment of personnel responsible for rescue or emergency medical aid
- 7. The preferred and any alternative means of notifying occupants of a fire or emergency.
- 8. The preferred and any alternative means of reporting fires and other emergencies to the fire department or designated emergency response organization.
- Identification and assignment of personnel who can be contacted for further information or explanation of duties under the plan.
- 10. A description of the emergency voice/alarm communication system alert tone and preprogrammed voice messages, where provided.

Requirements for Fire Drills:

- The first Fire Drill of the school year shall be conducted within the first ten (10) school days of the year
- Schools must conduct at least one physical evacuation drill monthly.
- Fire Drills shall be conducted at unexpected times and under varying conditions each month and shall include all occupants (IFC section 405) (i.e. during different class periods, during lunch, or between class periods).

- Where a school has a Fire Alarm system, Fire Drills shall be initiated using the Fire Alarm system
- All-Hazard Drills such as Lock-Down, Lock-Out, Tornado, HAZMAT, or Other Drills shall not replace the required monthly Fire Evacuation
- False alarms of the fire alarm system may not be substituted or used for a required evacuation drill or any other drill.

Lockdown plans

IFC section 404.2.1 says lockdown plans shall include the following:

- 1. Identification of individuals authorized to issue a lockdown order.
- 2. Security measures used during normal operations, when the building is occupied, that could adversely affect egress or fire department operations.
- 3. A description of identified emergency and security threats addressed by the plan, including specific lockdown procedures to be implemented for each threat condition.
- 4. Means and methods of initiating a lockdown plan for each threat, including:
 - The means of notifying occupants of a lockdown or any other emergency, which shall be distinct from the fire alarm signal.
 - Identification of each door or other access point that will be secured.
 - A description of the means or methods used to secure doors and other access points.
 - A description of how locking means and methods are in compliance with the requirements of this code for egress and accessibility.
- 5. Procedures for reporting to the fire department any lockdown condition affecting egress or fire department operations.
- 6. Procedures for determining and reporting the presence or absence of occupants to emergency response agencies during a lockdown.
- Means for providing two-way communication between a central location and each area subject to being secured during a lockdown.
- 8. Identification of a signal (or plan) for terminating the lockdown.
- 9. Identification of individuals authorized to issue a lockdown termination order.

- 10. Procedures for unlocking doors and verifying that the *means of egress* has been returned to normal operations upon termination of the lockdown.
- 11. Training procedures and frequency of lockdown plan drills.

Lockdown plan drills shall be conducted in accordance with the *approved* plan. Such drills shall not be substituted for fire and evacuation drills.

Active Shooter/Dangerous Intruder Lockdown Drills:

Lockdown, secure, or shelter drills could be conducted as a response to "active shooters," dangerous intruders or incidents presenting a potential danger to the school community.

In addition to full scale school-wide drills, other forms of training and familiarization exercises for these kind of emergencies might include:

- Table-top exercises with staff to ensure procedures are understood.
- Explaining procedures to students and staff with visual aids.
- Conducting small drills with smaller groups of students/staff.
- Practicing procedures to move small groups to safe locations (if applicable)
- Recording (with video) drills conducted by staff and emergency services using a limited number of actors and utilizing video to educate students in procedures.
- Upon activation of a fire alarm signal, employees or staff shall immediately notify the fire department.
- No person shall, by verbal or written directive, require any delay in the reporting of a fire to the fire department.

Recordkeeping

Records shall be maintained of required emergency evacuation drills and include the following information:

- 1. Identity of the person conducting the drill.
- 2. Date and time of the drill.
- 3. Notification method used.
- 4. Employees on duty and participating.
- 5. Number of occupants evacuated.

- 6. Special conditions simulated.
- 7. Problems encountered.
- 8. Weather conditions when occupants were evacuated.
- 9. Time required to accomplish complete evacuation.
- Fire safety, evacuation and lockdown plans shall be reviewed and updated annually or as necessitated by changes in staff assignments, occupancy or the physical arrangement of the building, including initial plans and any modifications
- Fire safety, evacuation and lockdown plans shall be available in the workplace for reference and review by employees, and copies shall be furnished to the fire code official for review on request.
- Lockdown plans shall only be permitted where such plans are approved by the fire code official.
