#### YVP Grant Updates: Awardees Notified!

• We're excited to announce that the awardees for the Youth Violence Prevention (YVP) grants have been officially notified! Congratulations to all successful applicants. To kick off the program, a Youth Violence Prevention Specialist Meeting is scheduled for January 11. During this session, awardees will have the opportunity to meet our grant unit and receive essential training on reporting. The Youth Violence Prevention Grant, established with <u>SB23-241</u>, allocated one million dollars for school or community violence prevention and intervention projects. The OSS received 42 grant applications with a request for close to \$4.5 million. Thanks to everyone who applied. Thirteen recipients received funding. A revised list is below:

# SRO Supervisors' Training

- The Office of School Safety will hold a NASRO Supervisors' Training in collaboration with the annual CASRO Summer Conference on June 10th, 11th and 12th at Keystone.
- This opportunity is provided by a Bureau of Justice grant secured by the OSS. This means that the grant funds will cover the cost of the NASRO training fee, hotels, per diems and mileage for SRO Supervisors.

- It is a contract with NASRO and not open to anyone outside of Colorado so it will NOT be listed on NASRO's website.

#### New Opportunity - Project Unite

- The staff of the CSSRC, along with partners from the Center for the Study and Prevention of Violence and CDE, have been trained for a new NASRO course called *Project Unite: The Four Integrated Systems of School Violence Prevention.*
- This training provides instruction on each key violence prevention system, and best practices for implementation.
- Modules include group discussion and team exercises to assist multidisciplinary school safety teams as they assess their current school safety systems and identify gaps and areas for improvement.
- Time is allotted for school safety teams to develop a violence prevention action plan in support of safety for their school.
- Upon completion of this course, multidisciplinary school safety teams will possess knowledge to implement violence prevention initiatives using a systems approach and be equipped with an actionable plan and next steps for strengthening their own school's safety. Participants will also receive a participant manual containing tools and resources to assist in planning and implementation efforts.
- The training is 16-hours or two days which could be split over a period of time.
- It is intended for school safety teams including an administrator, SRO or community law enforcement partner, school mental health professional and anyone else on the school's safety team.
- $\circ~$  We are in the process of recruiting sites to present this program under a BJA STOP Violence grant.
- If participants attend outside of their contract time, compensation at their normal rate is available.

# NEW NOAA Boulder Pen Pal Mentors Program

- NOAA in Boulder has about 1,000 people working in support of weather and space weather forecasting, and understanding our climate, atmosphere and oceans.

# Experimental Program: Invent2Prevent(I2P)

- <u>Invent2Prevent (I2P)</u> is an experiential program that challenges high school and university students to create and implement peer-developed initiatives, products and tools to prevent targeted violence, hate crimes and terrorism. The program allows essential prevention work to happen at the state and local level with the goal using a public health-informed approach to reducing risk factors and increasing protective factors within youth.
- The program is free of charge and sponsored by the <u>DHS Center for Prevention Programs</u> and <u>Partnerships</u>. Invent2Prevent is managed by <u>EdVenture Partners</u> and <u>McCain Institute</u>,

who work with students throughout the entire project period in a guiding, mentoring, and coaching capacity.

- Five students, the faculty and a chaperone from each of the top three high school teams are awarded an all-expense trip to Washington, DC to present to DHS leadership and compete for \$9,000 in prize money. Graduating seniors are eligible to apply for scholarship money.
- Thirty-five spots will be made available to high schools for the spring 2024 academic period on a first-come first-served basis.

- The hotline provides information on the process to file for an order and relevant resources. Coloradans may call the hotline at <u>855-999-3776</u> (ERPO).
- The hotline does not provide legal advice or serve as an avenue for an individual to file a petition for a temporary order. It also does not advise callers on the consequences related to the filing or false filing of a petition for a temporary Extreme Risk Protection Order.
- The hotline may refer callers to the appropriate venue to file the order for further information concerning the results of filing the order.

NEW Federal Government Announces Partnership to Distribute Free COVID-19 Tests to Schools

- <u>The U.S. Department of Education (ED)</u> and the <u>Administration for Strategic Preparedness</u> <u>and Response</u>, a division within the U.S. <u>Department of Health and Human Services (HHS)</u>, announced a partnership to <u>distribute free COVID-19 tests</u> to schools across the country.
- In a <u>letter</u> sent to local education agencies by ED, school districts are being encouraged to order tests directly from the federal government. Districts can then distribute these tests for free to students, staff, parents, and school communities, with the expectation that millions of tests will be sent out in the coming months allowing schools to stock nurses' offices, distribute at events, send tests home with students or parents, and more.

#### **NEW** FCC Proposes Creation of Schools and Libraries Cybersecurity Pilot Program

- The <u>Federal Communications Commission</u> proposed the creation of a <u>Schools and Libraries</u> <u>Cybersecurity Pilot Program</u> that would allow the Commission to obtain valuable data concerning the cybersecurity and advanced firewall services that would best help K-12 schools and libraries address the growing cyber threats and attacks against their broadband networks.
- The proposed pilot program, which calls for an investment of up to \$200 million over three years, would be established within the Universal Service Fund, but separate from the Commission's E-Rate program.
- In addition, the program would provide funding to eligible K-12 schools and libraries to defray the qualifying costs of receiving the cybersecurity and advanced firewall services needed to protect their E-Rate-funded broadband networks and data from the growing number of school and library-focused cyber events.

#### NEW Resources Related to the situation in Israel from SchoolSafety.gov

- In the wake of the October 7 Hamas attacks in Israel and subsequent conflict, many Jewish, Muslim, Israeli, Arab, and Palestinian students report that they feel unsafe at school.
- SchoolSafety.gov hosts a range of resources to support schools and help ensure students are free to learn in a safe, inclusive environment. NEW Students Experimenting with Fire: A Message from the CO Division of Fire Prevention and Control

- The <u>Division of Fire Prevention and Control (DFPC</u>) wants to support you, your staff, and your students. Did you know that a student usually starts multiple fires before getting caught? Experimenting with fire without adult supervision requires professional intervention, as these fires could stem from curiosity, crisis, thrill-seeking, willful destruction/delinquency, or mental health needs.
- To maximize public safety, please remember the following:

- Reporting fire-related incidents is a requirement and the responsibility of principals/administrators;
- Reporting an unwanted fire on school grounds or under school control is required by law; and
- In addition to the local fire jurisdiction, ALL fire incidents on school property (regardless of intent, magnitude of fire, or age of the person(s) involved) need to be reported to the Division of Fire Prevention and Control using this <u>Fire Reporting</u> <u>Form</u>.
- <u>DFPC</u> can refer youth who demonstrate firesetting behaviors to Youth Firesetting Intervention Specialists (YFIS), who are specially trained members of the Fire Service. They do not use scare tactics, and youth who have gone through a YFIS program have very low recidivism rates.
- <u>DFPC</u> is happy to serve you to keep your community safe!

# NEW UNLV Shooting Misinformation Highlights Need for Effective Campus Emergency Notification Strategies

- The December 6 mass shooting at the University of Nevada, Las Vegas (UNLV) led to a flood of social media posts filled with inaccuracies that led to the widespread dissemination of misinformation on the tragedy.
- One post on X (formerly Twitter) that said "FBI coverup incoming" in response to news coverage was reposted by more than 600 users and was liked more than 1,500 times, reports the Las Vegas Sun. This one post pushed down in the tags legitimate updates from the campus, law enforcement, and real news organizations, making it more difficult for people to get accurate information on the unfolding situation.
