



## -Accomplishments for July 2023- June 2024 (OSS Grant & Agreements)

The [Grants Unit](#) consists of two team members including: the unit manager and a grant analyst. We continue to successfully manage four grant awards including: School Access for Emergency Response Grant Program (SAFER), School Security Disbursement Program (SSD), Youth Violence Prevention Grant Program (YVP), and the Enhanced School Safety Incident Response Grant (ESSIR) within the Office of School Safety Grants Unit. We are currently administering four segments of ESSIR, two segments of SAFER, one segment of YVP, and two segments of SSD. We currently partner with ESSIR (1), YVP (13), SSD (2024-68, 2023-62) SAFER (2025-10, 2024-13) 167 awardees to administer grants that drive the mission of the OSS.

- **Process Improvement:** -
  - Implementing formal processes for grant administration for all grants (School Access for Emergency Response Grant Program (SAFER), School Security Disbursement Program (SSD), Youth Violence Prevention Grant Program (YVP), Enhanced School Safety Incident Response Grant (ESSIR)) within the Office of School Safety Grants Unit from the inception of the award (request for proposal and application) through closeout (monitoring). We also worked alongside the Office of the State Controller to come up with a formalized process that allows the agreements, CORE entry, signature process, and notifications to be more streamlined.
  - Working closely with finance to create a financial process for efficient payment and budget revisions.
  - Publishing a thorough grant management guide for all grants, that provided grant recipients with actionable guidance that streamlined the grant and program management, and a guidance that provided enforceable guidelines and procedures for the state. This management guide made grant/program management efficient and effective while making the process consistent across all grant programs.
  - Using the grant management guide, individual application handbooks were created for each grant.
  - Implementing a different email address for each grant program streamlining communications, ensuring that it stays organized, and that each email is answered within a reasonable period of time.
  - Creating formal documents and forms for each part of the grant administration process including: Grant Change Request, Request for Reimbursement, Quarterly Progress Report, Official Closeout Letters, Official Grant Letters, Official Acceptance Letters, etc.



- o Requiring formal documentation for extensions for quarterly reports and request for reimbursements
- o Creating a detailed budget to actual report that documents the financial and programmatic progress of each grant.
- o The grants team took a process map training course to assist with efficiently and effectively creating and implementing processes.
- o Created a monitoring structure to ensure compliance among all grant programs administered.
- o Created and implemented a reporting review process.
- **Stakeholder Engagement:**
  - o Recently administered a survey to YVP grant recipients where we received an A rating in grant administration and customer service. The survey included 8 questions, requisition information on satisfaction on customer service and support level, response times, effectiveness and access to training and materials, professionalism, and overall satisfaction. We received an overall rating of 9.5 out of 10. I have included a copy of the survey below.
  - o We ensure that all grantees and potential grantees are aware of our open-door policy and willingness to meet.
  - o We have answered countless emails and phone calls related to each of the grant applications and administration.
  - o Hosting frequent webinars and training to ensure that potential awardee and current grant awardees are fully equipped with the information and resources needed to ensure that they are successful. These webinars included: Pre-Award Webinar, Grant Kick- Off Meeting, Recurring Grant Recipient Check-In Meetings, Reporting Requirements Training, Grant Closeout Meetings.
  - o We are implementing onsite visiting beginning the Fall 2024.
