#### Carl Blake – Chair (Juvenile Treatment Provider, Clinical Supervisor with DD/ID)

Since 2008 I have been an appointed member of the Sex Offender Management Board representing CDHS - DYS and overseeing DYS treatment, services, and programming for juveniles who have committed sexual offenses. I have been the chair of the Application Review Committee since 2010 and spend much of my time in committee meetings for SOMB and drafting various protocols for SOMB. Outside of work I spend a lot of time snowboarding, camping, and hiking. I moved to Colorado in 1996 to be closer to the mountains and leave the beach behind and I couldn't be happier.

## **Angel Weant – Co-Chair (Probation)**
